Simplified: Title IX

- 1** **What is it?** Title IX of the Education Amendments of 1972 was designed to limit discrimination by sex and sexual harassment in public schools and other government-funded institutions.*
- 2** **What does this mean?** Schools are prohibited from restricting admission or participation in activities based on sex. In terms of sports, male and female students must have equal opportunity for participation.*
- 3** **What are the consequences?** If a school is in violation of Title IX, a claim may be filed in court or with the Office of Civil Rights, which has the power to limit federal funding to that school — although that has never happened so far.*

Title IX is a federal civil rights law in the United States of America that was passed as part of the Education Amendments of 1972. This is Public Law No. 92-141, Education Amendments of 1972 - Patsy Mink - Gender identity under Title IX. No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance. Two female students have filed a Title IX lawsuit against Eastern Michigan University after it cut four sports teams in response to a budget. In 1972, a law was enacted to help prevent gender discrimination in the United States educational athletic system. This law, known commonly as Title IX, gives "No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance." Title IX, clause of the Federal Education Amendments, signed into law on June 23, 1972, which stated that no person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving. On June 23, 1972, the President signed Title IX of the Education Amendments of 1972, 20 U.S.C. et seq., into law. Title IX is a comprehensive federal law.
